PROGRAM OBJECTIVE

PROGRAM FEE

There is no program fee.

Program Duration

The program runs for **5 days**, commencing on **4** - **8 August 2025**. Participants should arrive at NWA by the evening of **3 August 2025** and plan departure after **19:00 hrs on 8 August 2025**.

Program Format

This being a residential program will be held at the NWA Campus at Pune.

Location

National Water Academy is situated on Pune-Sinhagad Road, between Nanded Phata and Kirkatwadi villages. Distance from key locations:

- Swargate Bus Stand: 12 km
- Pune Railway Station: 18 km
- Pune Airport: 29 km

Local Hospitality and Weather

NWA has a self-contained residential campus. Outstation participants will be provided accommodation in NWA Hostels. Meals are available on a **self-service basis** in the dining mess.

Lodging & boarding charges: ₹350/- per day (to be borne by participants). Local **pickup/drop** arrangements are the participants' responsibility. August falls in the **monsoon season**, with an average temperature around **25-30°C**.
